

**By-law No. GG-003: RESPECTING THE REMUNERATION OF THE MAYOR
AND COUNCIL OF THE TOWN OF GRAND BAY-WESTFIELD**

The Council of the Municipality of Grand Bay-Westfield under authority vested in it by *Local Governance Act, SNB 2017, c18* and amendments thereto enacts as follows:

SHORT TITLE

1. This By-law may be cited as the Remuneration By-law.

COMPOSITION

2. The Council of the Municipality of Grand Bay-Westfield consists of a mayor and six councillors elected at large.

REMUNERATION

3. The Mayor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$33,408.00 per year payable in equal monthly payments.
4. The Deputy Mayor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$16,495.00 per year payable in equal monthly payments.
5. Each Councillor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$14,328.00 per year payable in equal monthly payments.
6. Council may pass a resolution requiring any member of Council to forfeit all or part of his/her remuneration if such member has missed a minimum of three consecutive public meetings without an excuse that Council deems valid.

By-law No. GG-003: Respecting the Remuneration of the Mayor and Council of the Town of Grand Bay-Westfield

- 7.1 Each member of the Town of Grand Bay-Westfield Council is entitled to reimbursement for expenses incurred incidental to the discharge of duties as a member of Council provided such expense is not disallowed by motion of Council.
- 7.2 Reimbursement pursuant to subsection 7(1) shall be limited to reasonable expenses and made upon submission of receipts, plus a per kilometre rate, as established by resolution of Council, for use of a personal vehicle.
- 7.3 The Mayor of the Municipality shall be paid a per diem rate of \$115.00 per day for each day the Mayor attends meetings, seminars, conferences, training sessions and other like events as a representative of the Municipality outside the boundaries of the Municipality. The Deputy Mayor of the Municipality shall be paid a per diem rate of \$100.00 per day for each day the Deputy Mayor attends meetings, seminars, conferences, training sessions, and other like events as a representative of the Municipality outside the boundaries of the Municipality, except when acting for the Mayor she/he shall be paid \$115.00 per day.
- 7.4 Each Councillor of the Municipality shall be paid a per diem rate of \$100.00 per day for each day the Councillor attends meetings, seminars, conferences, training sessions, and other like events as a representative of the Municipality outside the boundaries of the Municipality.
- 7.5 On the first day of January in each and every year the remuneration set out in Sections 3, 4, and 5 shall be adjusted by an amount equal to the average increase in the Consumer Price Index (CPI) for New Brunswick recorded for the immediately preceding fiscal year ending September 30th.

REPEAL

8. By-law No. 104, being Town of Grand Bay-Westfield By-law Respecting the Remuneration of the Mayor and Council of The Town of Grand Bay-Westfield, enacted on 5 May 2004, and all amendments thereto, is hereby repealed.


