

# Capital Improvement Plan 2024-2028



#### Introduction

A capital improvement plan (CIP) is a tool to aid organizations make effective budgeting decisions for large projects and purchases based on a municipalities strategic goals and objectives. A CIP is a multi-year plan that identifies capital projects and equipment purchases, assists in planning and scheduling and identifies funding requirements.

#### Benefits of a Capital Improvement Plan

- Identifies and prioritizes capital projects
- Allows for a systematic process for evaluating capital projects
- Links strategic plan and objectives to the capital and operational budget
- Informs the public of a municipalities investments in infrastructure and equipment

#### Process of Preparing the Capital Improvement Plan



The CIP process is an ongoing cycle, each year existing and new projects are evaluated by a set criteria, this criteria is the used to aid in the prioritization of projects. Based on availability of funds and operational needs projects are allocated to certain years. Maintenance of assets is an ongoing process managed in conjunction with the Towns standard operating procedures.



### **Summary of Capital Improvement Plan**

The proposed capital improvement plan for the Town of Grand Bay-Westfield outlines the capital investments in infrastructure and equipment for the years 2024-2028. The Towns CIP sets guidelines for the prioritization of capital projects as well as identifies the funding required and suggested source of funding.

The development of the CIP is a multistep process, staff identify future capital projects related to their respective departments. Each capital project is evaluated against scoring criteria, this scoring helps develop a ranking of potential projects. Projects are allocated to years based on operational requirements and according to available funds from the budget.

The amounts identified in this CIP are budget estimates and will continue to be adjusted each year as actual costs and more recent estimates are available.
