# BY-LAW NO. 104 TOWN OF GRAND BAY-WESTFIELD BY-LAW RESPECTING THE REMUNERATION OF THE MAYOR AND COUNCIL OF THE TOWN OF GRAND BAY-WESTFIELD PAGE 1 OF 2

The Council of the Municipality of Grand Bay-Westfield under authority vested in it by Section 36 of the *Municipalities Act*, R.S.N.B. 1973, c.M-22 and amendments thereto enacts as follows:

## SHORT TITLE

1. This by-law may be cited as the Remuneration By-law.

## **COMPOSITION**

2. The Council of the Municipality of Grand Bay-Westfield consists of a mayor and five councillors elected at large.

#### **REMUNERATION**

- 3. The Mayor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$10,000 per year payable in equal monthly payments.
- 4. The Deputy Mayor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$6,000 per year payable in equal monthly payments.
- 5. Each Councillor of the Town of Grand Bay-Westfield is entitled to remuneration in the amount of \$5,400 per year payable in equal monthly payments.
- 6. Council may pass a resolution requiring any member of Council to forfeit all or part of his/her remuneration if such member has missed a minimum of three consecutive public meetings without an excuse that Council deems valid.

#### ALLOWANCES

- 7.1 Each member of the Town of Grand Bay-Westfield Council is entitled to reimbursement for expenses incurred incidental to the discharge of duties as a member of Council provided such expense is not disallowed by motion of Council.
- 7.2 Reimbursement pursuant to subsection 7(1) shall be limited to reasonable expenses and made upon submission of receipts, plus \$0.30 per kilometer for use of a personal vehicle.

- 7.3 The Mayor of the Municipality shall be paid a per diem rate of \$75.00 per day for each day the Mayor attends meetings, seminars, conferences, training sessions, and other like events as a representative of the Municipality outside the boundaries of the Municipality.
- 7.4 Each Councillor of the Municipality shall be paid a per diem rate of \$50.00 per day for each day the Councillor attends meetings, seminars, conferences, training sessions, and other like events as a representative of the Municipality outside the boundaries of the Municipality.
- 8. This by-law comes into effect on May 25, 2004.
- 9. By-law No. 70, a By-law of the Municipality of Grand Bay-Westfield Respecting the Composition of the Council and the Remuneration of the Mayor and the Councillors is hereby repealed.
