Jeff Melanson – Project Engineer, Dillon Consulting presented the Report of a Hydraulic Assessment of Nerepis River identifying the two factors that result in flooding with two mitigation options to evaluate. The recommendation was to raise a 215 m section of the Brittain Road to a minimum elevation of 6.2 m providing a 100 year level of flood protection for both flow and downstream water level flooding.
