- continue to work in collaboration with all Fundy Region members including Local Service Districts to explore the development of a regional funding formula which would be presented before 2019-2020 ice season, subject to all the presentations to the five Municipalities being completed and all Municipalities and all Local Service Districts being in agreement to continue with the Regional Ice Strategy.


