BACKGROUND

Below is a section copied from the Provincial web page explaining the history of the now Canada Community-Building Fund.

"The Canada Community-Building Fund (CCBF), formerly known as the federal Gas Tax Fund (GTF), is a permanent source of funding provided to local governments biannually per the formula in the Canada-New Brunswick agreement. This funding program is for the construction, renewal, or material enhancement of infrastructure in our communities. Municipalities can pool, bank, and borrow against this funding, providing significant financial flexibility. Funding is also provided for projects in unincorporated areas (local service districts).

This infrastructure funding program started in 2005-06 with the signing of the *Canada New Brunswick Agreement on the Transfer of Federal Gas Tax Revenues under the New Deal for Cities and Communities 2005-2015.* In 2011, the federal government announced that this funding program would include a permanent annual investment of \$2 billion beyond 2014, across Canada. On May 20, 2014 the *Administrative Agreement on the Federal Gas Tax Fund (2014-2024)* was signed between Canada and New Brunswick...."

COMMENT

In late 2021, the Town received confirmation that it would receive an additional \$346,751 in funding from the CCBF. In order to receive the additional funding, the Town was required to revise its current CCBF investment plan to incorporate the additional funding. At the time, these funds were allocated to street improvements for 2023. Subsequent to this revision and during capital budget planning for 2022, it was decided to use \$257,369 of the additional CCBF funds towards the installation of the new solar array at the Sewerage Lagoon and direct the remaining \$89,382 to fund street improvements projects in 2022.

Gas Tax Application Revision

In order to utilize the additional CCBF funds for the solar array and street improvement projects in 2022, the CCBF Capital Investment Plan needs to be revised and submitted to the New Brunswick Department of Environment and Local Government for their review and approval.

FINANCIAL IMPLICATIONS

The revised investment plan will allow the additional CCBF funds to be allocated to the solar array and street improvement projects in 2022.

RECOMMENDATION

That the revised 5-Year Capital Investment Plan be approved to reflect the re-allocation of CCBF funding of \$346,751 from 2023 to 2022.

First Class Cleaners has been providing Janitorial Services since January 2019 and has an option to renew for two (2) years with mutual consent based on providing the same services at the current cost. The janitorial services is for various services at the following municipal buildings: Grand Bay-Westfield Community Centrum, Grand Bay-Westfield Works Garage, River Valley Lions Community Centre, Grand Bay-Westfield Fire Station No. 2, Brundage Point River Centre and the Splash Pad washroom and change room.

COMMENT

Staff has reviewed the email from First Class Cleaners and agrees with the recommendation of this Report.

FINANCIAL IMPLICATIONS

Janitorial services is an annual budget item for the Recreation Department, River Centre, Fire Department and Works Department.

BACKGROUND

A Strategic Priority for Council is Infrastructure Sustainability and Climate Adaptation. The Town has begun work on the 70kW Solal Array at the Sanitary Sewerage Lagoon, at 33 Shannon Road. With the addition of 64.08 kW DC currently under construction, this will bring the system up to 70kW once operational (added to the existing 5.28 kW pilot project completed in 2021). Completion of the Project is anticipated by the end of September.

COMMENT

Changes to the Commercial Building Retrofit Program came into play during the summer and the Town in co-operation with The Smart Energy Company, proceeded with an application through NB Power. A Feasibility Study to complete the Program requirements was undertaken, anticipating an estimated 296.32 GJ of energy to be saved annually.

FINANCIAL IMPLICATIONS

The Commercial Building Retrofit Program provides Refunds up to \$1,100 towards the Feasibility Study and a Grant of \$60.00/GJ or 21.6¢/kWh produced by the panels. Our application to the program was received on September 12, 2022. A \$17,779.20. grant is anticipated at the end of the project.

RECOMMENDATION

That the Council of the Town of Grand Bay-Westfield receive and file the Feasibility Study as prepared by The Smart Energy Company.
