

**By-law No. GG-005: RESPECTING RIDESHARING**

The Council of the municipality of Grand Bay-Westfield under authority vested in it by Section 75 of the Community Planning Act, 2017 C19 enacts as follows:

The Council of the Town of Grand Bay-Westfield under authority vested in it by Section 10 of the *Local Governance Act*, 2017 and amendments thereto enacts By-law No. GG-005 Town of Grand Bay-Westfield Rideshare By-law.

Being a By-law of the Town of Grand Bay-Westfield to enable ridesharing within the Town limits.

Whereas Section 197.1 of the Motor Vehicles Act states: "No vehicle-for-hire company shall carry on business or facilitate the offer of vehicle-for-hire services within the territorial limits of a local authority unless authorized to do so by the local authority"

1. If a ridesharing agency is in good standing and licensed by any New Brunswick municipality, they are authorized to operate within the boundaries of Grand Bay-Westfield.
2. This By-law comes into full force and effect upon third and final reading.
3. Should a ridesharing operation not be in good standing and licensed by any New Brunswick municipality, then they may be subject to Administrative Penalty

A person who contravenes a provision of this by-law may pay to the municipality an administrative penalty in the amount of

- a. where the person has not previously contravened this by-law, \$100, and
- b. where the person has previously contravened this by-law, the sum of the amount paid or to be paid by the person in respect of the most recent contravention and \$100, provided that in no event shall a person be required to pay an administrative penalty in an amount exceeding \$1,500.00,

and, upon such payment, the person who committed the contravention is not liable to be prosecuted therefor.
