## 3) Draft By-law #67, Reduction of Single Use Plastic Bags

NOTICE OF INTENTION TO ADOPT A BY-LAW TO REDUCE SINGLE-USE PLASTIC BAGS DRAFT By-law #67 Respecting the Reduction of Single-use Plastic Bags. PURSUANT TO SECTION 15 and 70 OF THE LOCAL GOVERNANCE ACT, S.N.B. 2017, C. 18, PUBLIC NOTICE IS HEREBY GIVEN that the Council of the Town of Grand Bay-Westfield intends to consider a proposed by-law to reduce single-use plastic bags.

The subject matter of the Draft By-law No. 67 is as follows:

- Short Title
- Definitions
- Check-out bag prohibitions
- Exemptions
- Enforcement
- Offenses
- Severability
- Commencement

Any person may inspect the proposed by-law on-line at the Town's website www.town.grandbaywestfield.nb.ca or at the Town Office at 609 River Valley Drive during regular office hours 9:00 am to 5:00 pm Monday through Friday, Holidays excepted.

The Council has set the regular Council meeting of Monday February 22, 2021 commencing at 7:30 pm for Third Reading of the proposed By-law. Persons who wish to provide written support or objection in advance of the Public Meeting may do so by contacting the undersigned. Any person who wishes to speak for or against the proposed By-law must PRE-REGISTER with the Town by calling 738-6425.

The health and safety of our residents is of the utmost importance. Those attending the Public Hearing in person will be asked to wear a mask and observe the appropriate social distancing measures. Disposable masks will be provided to those entering Grand Bay Room should they not have one. Pre-registration for Virtual Meeting attendance, should it still be required, must be made through the Town Office prior to Friday February 19, 2021.
